

The following are highlights from the Winston County Board of Education meeting on August 9, 2007:

The Board approved payment to School Superintendents of Alabama for System Membership Dues in the amount of \$5,887.20.

Dr. Neil Hyche will be contracted as the outside data collector for PEPE evaluations of principals and central office personnel for the 2007-2008 school year.

Professional Surveying Services are approved as follows:

- Addison School Complex from Dutton, Webb, and Associates in the amount of \$2,800.00
- Meek School Complex from Dutton, Webb, and Associates in the amount of \$2,800.00.
- Double Springs Middle School from APEX Surveying in the amount of \$3,000.00.
- Lynn School from APEX Surveying in the amount of \$3,000.00.

Approval was given to apply for a Dropout Prevention Advisor Grant and Preparing Alabama Students for Success Initiative Grant.

Commendations made at the meeting are as follows:

- Jeff Richard of Winston Machinery for installation of handrails on the sidewalk between the Lynn Elementary School Buildings.
- Received \$400,000 grant for Distance Learning

Approval was given by the Board to submit the following projects to the State Department of Education for the 2007-2008 school: NCLB Title I Part A, NCLB Title II Part A, NCLB Title V Part A, ESEA Title IV (Safe and Drug Free Schools), At-Risk, IDEA Part B Title VI-B, Act 106 Plan and IDEA Part B Pre-School Program.
